Type	Subsidy Program （Prefectural Subsidy）
Division in Charge	Industry Digitalization Promotion Division
Eligible Companies	Information and communication technology related businesses

Subsidy Details

	Subsidy for fixed asset investment etc.
Details	Subsidy based on fixed asset investment and rental costs related to the establishment of the eligible facilities
Eligible Facilities	Development centers or headquarters etc. (offices, development or training centers capable of operating as headquarters, but excluding administrative offices)
Subsidy prerequisite	The total fixed asset investment and rental costs (over 5 years) of the new eligible facilities must exceed the following amounts. <ul style="list-style-type: none">• Sendai City: 10 million JPY• Municipalities other than Sendai City: 1.5 million JPY

Specific contents

	Subsidy for employment
Details	A subsidy will be granted upon the establishment of eligible facilities and will depend on the number of new employees
Eligible facilities	① Development centers or headquarters, etc. (office, research institute or a research institute that functions as headquarters.) ② Operating offices (back offices, BPO offices, etc.)
Subsidy prerequisite	【In the case of development centers or headquarters, etc.】 More than the following number of new employees hired a year (or 2 or 3 years) after the facility opening <ul style="list-style-type: none">• Sendai City: Five new employees• Municipalities other than Sendai City: Three new employees 【In the case of operating offices】 More than the following number of new employees hired a year (or 2 or 3 years) after the facility opening <ul style="list-style-type: none">• Sendai City: Ten new employees• Municipalities other than Sendai City: Five new employees

Subsidy amounts

Eligible Facilities	Subsidy Amount	Maximum Subsidy Amount
Development centers or headquarters, etc.	300,000 yen per person (or 600,000 yen per person if the new employee is a new graduate of an educational institution in the prefecture)	10 million yen (×3 years)
Operating offices	300,000 yen per person (or 150,000 yen per person if the new hire is a fixed-term employee)	5 million yen (×3 years)
