- 3. Main Content of Inquiries Asked During Assembly

Sixteen assembly members asked general inquiries in regards to the Governor's position and the framework for establishing a new medical department within a prefectural academic institution rather than supporting the establishment within a private academic institution, the wide-area disaster prevention base project and other issues.

- (1) Regarding the framework for establishment of a new medical department
 - Inquiry: Please explain the reason for changing positions from supporting private academic institutions to establishing a prefectural medical department
 - Response: After accepting the abandonment of plans created by universities including Tohoku Fukushi University and receiving requests to create a prefectural medical department, the prefecture reconsidered this issue. As a result of those deliberations, the prefecture decided to establish a new prefectural medical department.
- (2) Regarding the wide-area disaster prevention base
 - Inquiry: Please explain the acquisition of land
 - Response: Discussions were held among Miyagi Prefecture, Sendai City, Sendai Medical Center and Japan Freight Railway Company in January of last year. The institutions reached a basic consensus to carry out studies on the construction of a wide-area disaster prevention base, and studies have begun.
- (3) Regarding Sendai Airport
 - Inquiry: From the visit to Gold Coast Airport, it was confirmed that the airport is carrying out efforts to increase both its convenience and profit. Please explain those efforts in detail.
 - Response: In the international flight area of the Gold Coast Airport, efforts to improve airport convenience

for passengers include the establishment of duty free shops in the heavy customer traffic areas near immigration counters, which also connect to the increase in revenue for dining and other establishments. Based on these profits, the airport was able to establish flexible landing fees and successfully increase the number of flight routes and passengers.

(4) Regarding Onagawa Nuclear Power Station Unit No. 2

Inquiry: Should we not establish an inspection committee that will maintain independence and be able to conduct inspections from diverse aspects in order to verify safety?

Response: There are many issues that must be confirmed and highly technical, therefore the opinions of experts are being heard.

(5) Disaster Public Housing

Inquiry: Please explain the timeframe for the completion of construction

Response: Due to the delay in land acquisition and construction, the lack of materials and engineers, and the conditions of each municipality, it is unavoidable for the completion of construction of disaster public housing is estimated to be no earlier than FY2016 or later.
